### Support Birkenhead School Foundation Trust A Plea from Lorraine Dodd, Governor and Chair of Birkenhead School Foundation Trust

How many of you are aware of Birkenhead School Foundation Trust? Do you know how it supports the whole School? You might have read about the School's vision to fund transformational bursaries but did you realize that the Foundation Trust is a key element in the strategy to achieve this?

I was asked, many years ago, whether I would join as a Governor, although my experience of public schools, especially

those for boys only, was distinctly limited! This was seen as an advantage as I could ask the 'stupid questions' as a newcomer (supported by my OB Prep husband) and my work in investment management might come in useful. The rest, as they say, is history and what changes I have seen over the intervening years.

There have been so many improvements with the physical development and



refurbishment of the School campus and sports facilities. Important though these are, the emphasis on the ethos of the whole School, Seniors and Prep, has created a welcoming and supportive environment in which every student can aspire to achieve their potential to the best of their abilities and talents.

Becoming a co-educational School was transformational and, quite rightly, is now taken for granted. Our School has grown significantly in student numbers together with its reach into the local communities but more needs to be done.

The main objective of the Foundation Trust, a charity created in 1998, is to support the activities of the School mainly but not exclusively to provide bursary funding out of income. I know how important it can be to a family to get that extra help with fees through a bursary and there will be a number of you, as an OB, who remember the impact of the direct grant and assisted places schemes whether for you personally or one of your school friends.

Looking ahead, our aspiration is to provide increased bursary support in a way which is truly transformational, 'the ethos of the whole School has created a welcoming and supportive environment in which every student can aspire to achieve their potential'

including acting as a catalyst for social mobility in our local communities.

Investment in the School's staff and its facilities remains so important in delivering a positive educational and cocurricular experience for all our students, now and in the future.

### With Thanks' from OB Charlotte Cullen ('11 -'18)

I joined Birkenhead School in 2011, starting in Year 7. Due to the kindness and sheer generosity of donors, I was eligible to be the recipient of a bursary which covered 80% of my fees. Without this, I wouldn't have been able to come to Birkenhead, so it inspired me to make the most of an outstanding, focused, and tailored education programme that I might not have received at another school.

Throughout my years as a pupil, I fully immersed myself academically and through extra -curricular activities. Mainly participating in sport, I was Netball captain from Year 7-10 and enjoyed being a member of various other teams. I was also active within the Music Department, performing as part of the 'Cantata Choir' and receiving regular piano lessons. However, the highlight was my appointment as Head of School in 2017. This was the greatest honour I had received to date, and I strove to use this position to both add value to the school but also to give back as I had received so much time, support, and dedication from staff throughout my school career. From this, year upon year, I grew, matured, and was challenged to be the best I could be. This is something which has stayed with me throughout my professional career so far. Birkenhead has also taught me the art of resilience, one of the most important attributes that I believe a person can have, and for which I am so grateful.

At such a young age, it is difficult to decide exactly what you want to do with the rest of your life, but through extensive support from the careers service and subject teachers during Sixth Form, I finally decided I wanted to study Law at University. Upon receiving an offer from the University of Sheffield, I moved in 2018 and quickly discovered that I wanted to pursue a career in Law, as a Solicitor, after graduating. Due to both the exceptional academic standards and unwavering support that was afforded to me, Birkenhead School provided so many opportunities during my time that allowed me to be at the top of my game when applying for prospective job openings. As you may well know, the process for receiving a training contract is extremely competitive, with many applicants applying for a handful of places.

'Birkenhead School provided so many opportunities that allowed me to be at the top of my game' With just one place available, and after a gruelling seven stage recruitment process, I was offered the training contract with a Law firm in Sheffield called Kennedys. During feedback, I was informed that I had stood out from my competitors due to my experience, skills, and resilience, which had largely been shaped by my time at Birkenhead. Kennedys have been kind enough to fund my Solicitors Qualifying Exam, which I am completing part-time, whilst working in the Healthcare department. In just less than two and a half years, I will be a fully qualified Solicitor.

Starting in late September this year, I have primarily worked on clinical negligence claims for our biggest client; NHS Resolution, but I also have worked for private healthcare clients such as Spire, and Nuffield Health. There is a common stereotype of big law firms that their junior staff are mistreated in the sense that they are forced to work long hours with little exposure to work. However, in just under two months, I have aided on multi-million-pound cases and have had the opportunity to shadow lawyers in many instances, such as at inquests and other external conferences with the Courts.

Looking back, I feel so grateful for my time at Birkenhead School. From the unparalleled academic standards and personal support to the wealth of extra-curricular opportunities, Birkenhead has provided me with a plethora of skills and attributes to



become not only professionally successful but a well-rounded person. Without the continued support and generosity from donors like mine, I can say with absolute certainty I wouldn't be where I am today.

### Why I Give An OB reflection

## The Foundation Trust

For many decades, children from across Wirral have benefited from the outstanding all-round education available at Birkenhead School, with many of them going on to take up responsible positions in society.

They were able to do this irrespective of social status or parental means during the era of Direct Grants and Assisted Places, which is now long gone. There remains the opportunity for the School, thanks to generous benefactors, to support attendance for those who would otherwise find the fees prohibitive.

Many give to acknowledge the opportunities that opened up for them through attendance at Birkenhead School, some recognising financial assistance from which they benefited or keen to enable other children to have the best possible educational foundations and opportunities.

The School welcomes all gifts to the Foundation Trust, which will be used to provide support to those students who will gain most from it.



#### How contributions will be used

Since its inception in 1998, the Foundation Trust has supported students to a value in excess of  $\pounds 1$  million and there are currently around 75 students in School receiving support from the Foundation Trust Bursary Scheme.

The majority of the fund is managed by Rathbone Investment Management, and the Trustees include Governors of the School, the Headmaster, the Senior Deputy Head, and the Head of Prep.

All donations are gratefully received and will be put to good use. Gifts or bequests of  $\pm 13,000$  or more (currently equivalent to approx. one year's fees), with the donor's or executor's permission, will be acknowledged on the Benefactors' Board in Bushell Hall.

The Trustees wish to extend their warmest thanks to all benefactors and to stress the importance of the fund in enabling children to access the quality of education offered by Birkenhead School.

> By way of illustration: If 40 donors gave £30 per month for 7 years, this would enable a full 'Access Scholarship' for a child to attend the School from Year 7 through to Sixth Form, setting them up for life.

In carrying out their duties, the Trustees will exercise due diligence in the way they invest and use donors' money to the benefit of children at the School. Donors are welcome to give to general funds or to restricted funds to be used for a specific purpose.
